The Avengers Bowling Club proudly presents the 25th Annual Memorial Tournament Rules & Format

- ELIGIBLE:** The Avengers tournament is open to members of USBC. Bowlers must have a current 2007-08 membership card. Tournament is USBC sanctioned.
- ENTRY DEADLINE:** Entry close August 31, 2008, at the last squad.
- ENTRY FEE:** The DOUBLES EVENT entry fee is \$17.00 per bowler (\$34.00 per doubles team). The TEAM EVENT entry fee is \$17.00 per bowler (\$68.00 per four-person team). The full amount of the entry fee must accompany the entry form. Entry breakdown: Lineage and expenses \$8.00; Prize fund \$9.00.
- PRIZE MONEY:** Prize fund will be paid 100% in every event. Prize ratio is 1:10. Payoff within 30 days.
- AVERAGES:** Bowlers must use their highest USBC sanctioned book average (based on a minimum of 21 games) for the 2007-2008 season. If none, use the highest USBC sanctioned league average (21 games or more) from the 2006-07 season. If none, use the highest current USBC sanctioned league average (21 games or more). If none, bowl scratch. Rule #319a, Item 3 will be enforced.
- HANDICAP:** Handicap will be 90% from 230.
- FORMAT:** Bowlers will bowl three games on one pair of lanes.

- SUBSTITUTES:** Once a replacement has started to bowl, the replacement must finish the event being bowled.
- TARDY:** A bowler arriving late for an event will be allowed his/her score to start with the frame he/she is ready to bowl. Any frames missed will receive zero.
- MULTIPLE ENTRIES:** Bowlers may enter the TEAM EVENT as many times as they wish. Teams must consist of two different team members to cash more than once. Bowlers may enter the DOUBLES EVENT as many times as they wish but may cash only once with the same partner.
- TEAM COMPOSITION:** TEAM EVENT teams may consist of any combination (men or women) with at least one member of the opposite sex. DOUBLES TEAMS may be any combination (men or women).
- AVERAGE VERIFICATION:** Averages will be verified by the tournament committee. USBC Rule 319a-2, 319d, and 319e will not apply. Note: Misrepresenting average or bowling ability may be cause for disqualification and forfeit of entry fee.
